POLICY STATEMENT – B1

Bowling Tournaments

1.0 General

This statement establishes the parameters by which bowling tournaments and special events may be conducted in the Sports Pavilion, the authority of the Sports Pavilion Manager with respect to such tournaments and special events, and the fees charged.

2.0 Authority

The Sports Pavilion Manager shall have the authority to grant or deny requests for bowling tournaments or special events to be conducted in the Sports Pavilion and, subject to this policy, shall establish the parameters and controls by which the tournament or special event shall be conducted. The Sports Pavilion Manager has the authority, upon approval of the Deputy General Manager to preempt any tournament or special event, when necessary, and to establish deadlines by which non-house tournaments or special events are to be scheduled.

3.0 Special Events

Non-tournament special events may be held in the Sports Pavilion at the discretion of the Sports Pavilion Manager. Such events shall be open only to Recreation Centers of Sun City West members and their guests.

4.0 Nonresident Participation

The Sports Pavilion Manager may authorize nonresident participation in bowling tournaments as long as the tournaments are not Sun City West championships and as long as Sun City West residents are given priority in registering for such tournaments.

5.0 House Tournaments

The Sports Pavilion Manager may authorize and/or conduct such bowling tournaments as (s)he may deem to be in the benefit of the Recreation Centers and such tournaments shall take precedence over other tournaments. All fees, except those specifically identified for prize funds, shall be retained for the benefit of the Recreation Centers.

6.0 Member Sponsored Tournaments

Members of the Recreation Centers of Sun City West, Inc., the SCW Bowling Association and other SCW organizations may conduct bowling tournaments at the Sports Pavilion subject to the terms and conditions established by the Sports Pavilion Manager. Fees established for these tournaments shall include lineage charges and reimbursement of all direct costs, as established by the Sports Pavilion Manager and shall be so stated in a Letter of Agreement executed between the Sports Pavilion Manager and the tournament sponsor. All such Letters of Agreement shall be reviewed in advance by the Deputy General Manager.

7.0 Outside Tournaments

The Sports Pavilion Manager shall have the authority to solicit and accept bowling tournaments sponsored by non-Sun City West persons or organizations, which may or may not have participation by Sun City West residents. The fees established for said tournaments shall include, but not be limited to, lineage charges and reimbursement for all direct expenses incurred by the Recreation Centers in providing for such tournaments. To the extent possible, such tournaments shall not interfere with the conduct of member/member organization tournaments or the conduct of Sun City West league play. When possible, lanes 1-4 shall be retained for member open bowling during such tournaments.

8.0 Fees

- 8.1 All tournament fees shall include lineage charges, which shall not be less than the established member lineage charge.
- 8.2 All non-house tournament fees shall include a charge for, or reimbursement of, all direct expenses provided by the Recreation Centers to the tournament including, but not limited to, printing, secretarial service, prizes, food/beverage service, or any other special arrangements as estimated by the Sports Pavilion Manager.
- 8.3 Special event fees shall be set by the Sports Pavilion Manager and, in the case of non-house conducted special events, the Recreation Centers shall be reimbursed for all direct and indirect expenses involved in conducting said special event.

9.0 Appeals

Any disagreement between tournament or special event sponsors and the Sports Pavilion Manager may be appealed to the and through the Deputy General Manager to the General Manager, whose decision shall be final.
